## An Overview

The Adult Services Outpatient Program is an integral part of the continuum of care offered by DISC Village, Inc. Specializing in the treatment of substance abuse and/or other behavioral health disorders, we offer comprehensive outpatient and case management services to concerned individuals and families.

## Admissions

Admission is voluntary for adults seeking treatment for substance abuse and other co-occurring behavioral health issues such as mental health issues. During the initial consultation session, an evidence-based assessment of the individual's and family's needs and suitability for outpatient treatment is determined.

The consultation is ***confidential*** and without obligation to enter the program. Should an individual be considered inappropriate for the outpatient component, a referral to another program or service will be provided.

## Services

Outpatient services are provided by trained professionals experienced in assessment, diagnosis, and treatment of individuals and their families with substance use and other behavioral health disorders. We are committed to quality prevention, intervention, outpatient treatment and aftercare services directed toward long-term recovery. *Free HIV testing and education is also available.*

## Individual Counseling

The Adult Services program offers one-on-one counseling based on a program of complete abstinence. Family members are encouraged to participate with the individual in recovery, and significant others may participate in counseling and/or be referred for additional family or individual services. Specialty treatment levels are offered for adults and their families including:

- Intervention Counseling
- Outpatient Counseling
- Intensive Outpatient (IOP)

## Case Management

Case management services are an integral part of the continuum of care. Ongoing communication with the referring agency is offered as authorized by the consumer. Treatment plan reviews are conducted with the consumer on a monthly basis and referrals may be made to other community organizations agencies to meet legal, medical, psychiatric, educational, spiritual, vocational or other service needs.

## E-Therapy

The Adult Services Outpatient Program provides confidential online counseling electronically via the internet, phone and email. E-services are available to those individuals that may have difficulty accessing traditional face-to-face services due to lack of transportation, disability, living in a rural area, scheduling conflicts and other barriers. E-therapy provides Screening and Assessment, Individual Counseling, and Case Management.

## Confidentiality

It is imperative that confidentiality be observed for therapeutic progress to occur. Strict adherence to all Federal as well as Florida Statutes is maintained.

## Sliding Scale Fees

DISC Village understands economic or other hardships when needing services and will not turn a consumer away based on ability to pay. DISC Village will work with consumers and/or referral sources in regards to fees for services, including urinalysis testing, specialized drug testing, and HIV testing, based on a sliding scale.

## Quality Assurance

The program participates in continual internal and external reviews of all services to ensure the highest quality standards.
